Qualifying criteria for interested contractor/bidder:

1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies in appropriate class.
2. Minimum Annual Turn over from Construction works during last 3 consecutive years shall not be less than **294.00 lakhs**.
3. Should have **completed** satisfactorily RCC 3-storied building of (i) *one work* of value not less than **7.11 crores against single work order** **OR** (ii) two works of value not less than **4.45 crores** each against *two separate work orders* **OR** (iii) three works of value not less than **3.56 crores** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> **along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3**. Incomplete bid/documents shall be rejected without giving any reason.
5. Bidders will be required upload the scanned copies of the Demand Draft against tender fee (non-refundable) and Earnest Money drawn in favour of the Registrar, Tezpur University payable at Tezpur.
6. Signed hard copy of complete tender document along with (a) All supporting documents mentioned in the tender document (b) Original EMD and tender fee must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach **the Registrar, Tezpur University** before the last date & time for receipt of Bid.
7. Downloading of tender paper by a bidder does not automatically mean that the bidder is considered qualified for the work. Tezpur University reserves the right to accept or reject any or all the tender document without assigning any reason thereof .
8. The acceptance of tender will rest with the authority of Tezpur University, Napaam , Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
9. For any clarifications regarding site conditions, items of work or any other points/ conditions related to tender , the Executive Engineer, Engineering Cell, Tezpur University, Napaam may be contacted during office hours on all working days.
10. The tender document must be uploaded in two parts:

PART-A: This part contain the Techno-Commercial Bids comprising of NIT, General Conditions of Contract, Special Conditions of Contract, Technical specifications, drawings, any other matter the tenderer wish to upload duly signed with official seal etc.

PART-B: This part contain the Price Bids comprising of only the **BILL OF QUANTITIES (BOQ)** duly filled in and signed with office seals. No other paper other than the BOQ shall be accepted.
