- 2) Experience of having successfully completed similar works during last seven(7) years in any Govt./Semi Govt. Department/ Autonomous Bodies supported by work order and completion.
- 3) Valid Electrical contractors licence.
- 4) GST Registration No.
- 5) Average annual financial turnover during the last 3 years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
- 6) Application requesting issue of tender document must be accompanied by self-attested copies of qualifying document as per the qualifying criteria as stated in serial no1,2 and 3 above. Tenderers will be required to **deposit cash (non-refundable)** at the TU cash counter for purchase of tender document. The cash counter remains open up-to 1.00PM on all working days. TU reserves the right to accept or reject any or all the applications for issue of tender document without assigning any reason thereof.
- 7) The acceptance of tender will rest with the authority of TU, Napaam, Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
