Tenderers will be required to deposit Demand Draft in favour of **The Registrar, Tezpur University, payable at Tezpur** or **through any digital mode** at the University Cash Counter for purchase of tender document. **The cash counter remains open up-to 1.00 PM on all working days.** The Tender fee in non-refundable.
5. In case of digital mode payment receipt of the payment is to be submitted.

The acceptance of tender will rest with the authority of Tezpur University, Napaam, Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof.
