Qualifying criteria for interested contractor/bidder:

1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies, who award works, in appropriate class.
2. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> **along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria.** Incomplete bid documents shall be rejected without giving any reason. **There is no need to submit the hard copy of the Tender Document and other documents** except Original Declaration regarding correctness of information submitted in this Tender as per NIT in affidavit (As per Annexure V), Tender Fee (non-refundable) and Earnest Money Deposit(refundable)
3. Bidders will be required to upload the scanned copies of the Demand Draft against tender fee (non-refundable) and EMD (Earnest Money Deposit) drawn in favour of the Registrar, Tezpur University payable at Tezpur along with the Declaration regarding correctness as per NIT in affidavit and other qualifying documents as per tender and sealed and signed tender document.
4. Declaration regarding correctness of information submitted in this Tender as per NIT in Notarized Affidavit and Tender fee (non-refundable) and EMD (Earnest Money Deposit) must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach *The Registrar, Tezpur University* before the last date & time for receipt of Bid.
5. **Bidders are required to upload the following documents. Non-submission will lead to disqualification of the bid.**
 - (a) EMD and Tender Fee.
 - (b) Affidavit for correctness of information as per **annexure V**
 - (c) Bank Solvency Certificate in prescribed format (As per **Annexure-III** of this tender document) from any Scheduled commercial bank issued within 06(Six) months prior to the date of publication of this NIT or issued after the date of publication of this NIT satisfying at least 25% (twenty-five) of the value put to this tender.
 - (d) PAN.
 - (e) GST Registration.
 - (f) A valid electrical contractor's License.
6. **Bidder's Technical capability will be determined as per the format given in Annexure-VI. Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.**
7. **Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:**
 - a) Record of poor performance during the last five (05) years as on the date of Application such as abandoning the works, rescind of the contract for which the reasons are attributable to the non-performance of the contractor, in ordinate delay in completion, consistent history of litigation/arbitration awarded against the applicant or any of its constituents or financial failure due to bankruptcy.
 - b) Shown very poor performance in the implementation of works of Tezpur University.

8. Downloading of tender paper by a bidder does not automatically mean that the bidder is considered qualified for the work. Tezpur University reserves the right to accept or reject any or all the tender document without assigning any reason thereof .
9. The acceptance of tender will rest with the authority of Tezpur University, Napaam , Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
