The bidder, in case claims to be a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "**Bidder Turnover**" criteria, "**Experience Criteria**" and also from payment of **Earnest Money Deposit (EMD)**, subject to meeting of quality and technical specifications and . If the bidder is an **OEM** of the offered products, it would be exempted from the "**OEM Average Turnover**" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from **Turnover / Experience** Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. **Quotations should be accompanied by:**
  - i) An **EMD** (in the form of Demand Draft/Banker Cheque) for **Rs. 23,742/-** (Rupees Twenty Three Thousand Seven Hundred Forty Two) only drawn in favor of Registrar, Tezpur University, payable at Tezpur. **No request for consideration of earlier deposited EMD will be considered.**
  - ii) **Bidders who are MSME/NSIC registered** needs to furnish a "**Bid Security Declaration**" (format enclosed at Annexure – III) in lieu of EMD accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for a period of Three (03) years from participating in any future bid invited/published by Tezpur University. **Bidders who are MSME/NSIC registered seeking exemption from payment of EMD are to submit valid documents in support of their claim. Bidders seeking exemption are asked to clearly mention the category under which exemption is claimed. The category of exemption under MSME/NSIC will be strictly adhered to.**
  - iii) **The original copies of the EMD/Bid Security Declaration (Annexure-III) should be deposited/submitted/reach the office of the undersigned before opening of the Bids in an envelope superscribed as "Quotation/Participation Fee and EMD for Bid No.( State the Bid No. generated by GEM) addressed to the Deputy Registrar-S&P, Tezpur University. 5. Bidders/Tenderers are to ensure that they are GST compliant and that their quoted tax structure/rates are as per GST law. 11. **Technical Compliance** vis-à-vis Required Specification, i.e, line wise offered specification, on OEM Letterhead fulfilling of all requirements, with details of the OME Person signing the document, such as name, designation, address, e-mail Id and Phone No. must be mentioned. The same shall be verified with OEM and any material departure in offering shall render the submission disqualified. Please also note that the tenderer should not write 'As per Literature enclosed'. In such a case, offer shall not be considered.
12. **Validity of Quotation:** Quoted rates must be valid for at least **180 days** from the last date of submission of quotation.
13. **Manufacturer authorization:** Wherever Authorized Agency/ Distributors/Partners are submitting the bid, Manufacturers Authorization Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid. The Authorization must be addressed to the buyer and it should be bid specific from OEM.
14. OEM must be registered in India past 15 years or more and in continuously manufacturing and selling the same product line.
15. OEM should undertake that the quoted products are with 3 Years OEM Onsite warranty as per bid requirement and not of bidder. Undertaking for providing URL for verification of the warranty in the OEM website to be provided along with the bid.
16. OEM should undertake that no refurbished component will be used in the quoted products.
17. Malicious Code Certificate signed by the OEM and the Bidder: The seller should upload following certificate in the bid:
  - (a) *This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to:*
    - (i) *Inhibit the desires and designed function of the equipment.*
    - (ii) *Cause physical damage to the user equipment during the exploitation.*
    - (iii) *Tap information resident or transient in the equipment/network.*
  - (b) *The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software*
18. **Bidders Turn Over Criteria:** The minimum average annual financial turnover of the bidder during the last three years, ending on 31<sup>st</sup> March of the previous financial year, should be as indicated in the bid document. 19. Applicable levies, surcharge and discounts should be clearly indicated item wise.
20. **Product Quality Assurance: Motherboard, Monitor, Keyboard and mouse should be of the same OEM.** The name of the brand must be embossed or etched. Stickers / Paint shall not be accepted. Assembled PC in any case will not be accepted.
21. Quality Certificates: Valid certificate to prove that the products are genuine and of international standard, as mentioned below, must be uploaded: (a) Manufacturer's certificate; (b) ISO/ISI certificate.
22. Installation, demonstration, and training -sessions should be conducted/imparted by the selected bidder/ OEM for the delivered equipment as well.
23. **After Sales Service Guidelines (wherever applicable)::** In case of imported goods as well as local goods, bidders should clearly state the detailed address, contact number and email ids of 'after sales service centre' preferably in Tezpur/Guwahati, India or any place in Assam without which their offers shall be liable for rejection. Service against any complaint must be provided within 24hours.

25. **Payment:** 100% payment after successful delivery, installation and commissioning (if required in the scope of supply) and acceptance by the user.
26. **PENALTY FOR DELAYED DELIVERY:** The date of delivery should be strictly adhered to. In the event of delayed delivery, installation & commissioning, the vendor shall be liable for a penalty deduction as per prevailing rule.
27. The University is exempted from paying Custom and Excise duty.
28. Warranty/Guarantee applicable if any, period should be specifically mentioned in the quotation.
29. Irresposive/incomplete quote will be rejected.
30. **Performance Bank Guarantee amounting to 3(Three) % of the order value needs to be submitted in the form of Bank Guarantee in favour of "The Registrar, Tezpur University" on or before final settlement of the bill.** The Performance Bank Guarantee must remain valid for the entire period of warranty plus **60(sixty) days**. No interest shall be paid on the Performance Bank Guarantee.
31. **Conditional tenders not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Printed conditions mentioned in the tender bids submitted by vendors will not be binding on Tezpur University.
32. **Enquiry during the course of evaluation not allowed:** No enquiry shall be made by the bidder(s) during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s). - If the equipment or any of its component is found having poor workmanship, faulty designs, poor performance and bad quality of materials used.
- If the supplier fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by Tezpur University.
- If the supplier fails to perform any other obligation(s) under the contract.
- Under the above circumstances Tezpur University may terminate the contract / purchase order in whole or in part and forfeit the EMD/PBG as applicable. In addition to above, Tezpur University may at its discretion also take the following actions: Tezpur University may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate Tezpur University for any extra expenditure involved towards goods and services obtained. Besides, the Vice-Chancellor, Tezpur University, and reserves the right to impose any other form of penalty as deemed fit including blacklisting of the vendor.

**34. Selection criteria:**

**i. Evaluation Criteria:**

To ensure that each bidder has the necessary qualifications and resources to full fill its obligations under the contract, the following criteria shall be evaluated. The Eligibility, Financial, Experience & Support criteria should be passed before the technical criteria. Technical criteria will be evaluated and ranked by the award of 'ACCEPT' and/or 'REJECT' Only the 'ACCEPTED' vendors will be considered for price bid. In case a joint venture makes a bid, any one of the members of the joint venture need to be qualified for each of the criteria mentioned below.

**ii. Eligibility Criteria:**

- Any entity, which has earlier been debarred by Govt. of India from participating in its projects, would not be eligible for this tender.
- The firm should be profit making during each of the year, 2021 – 22, 2022-23, 2023-24. The Bidders audited Annual Financial Statements (Balance Sheet, Income Statement) for the last 03 (three) years shall be provided. Only the bidders having MSME registration are exempted from the above-mentioned condition.
- The bidder or the OEM should not be blacklisted by Tezpur University or any other Educational /R&D/ PSU/ Govt organizations. A certificate of Undertaking, duly notarized, must be submitted along with the bid.
- List of Engineers with the details of the service provider must be submitted.
- The Vendor should have at least one (01) year full-fledged service center in the NE region.
- Self-attested PAN, GST Certificate and Trade License must be submitted.
- Self-Attested copy of the registration certificate for the Company /Firm must be provided.


